Guest Speakers:

Keynote speaker Derwyn Bunton is the Chief District Defender for Orleans Parish (New Orleans). In 2007, Derwyn represented a client in the so-called Jena 6, which involved six black teenagers charged with beating a white student at Jena High School in Jena, Louisiana. Events preceding the alleged crime included the hanging of nooses from a tree in the high school courtyard after a black student had sat under that tree. The charges of the Jena 6 led to approximately 15,000 protesters marching in Jena in what was described as the "largest civil rights demonstration in years." Originally charged with attempted murder, Derwyn's client pled guilty to a misdemeanor and his conviction has since been expunged. Bunton also played a critical role in working through the post-Katrina indigent defense crisis in New Orleans.

Meda Chesney-Lind is nationally recognized for her work on women and crime. Her books include *Girls, Delinquency and Juvenile Justice*, which received an award from the American Society of Criminology. Her most recent work is an edited collection entitled *Female Gangs in America*. A Professor of Women's Studies at the University of Hawaii at Manoa, Chesney-Lind is an outspoken advocate for girls and women, particularly those who find their way into the criminal justice system.

John Conroy is an award-winning investigative journalist published in such places as the New York Times, Washington Post, Boston Globe, Chicago Tribune, and the Chicago Reader. He spent years exposing police torture in Chicago. Currently he is Director of Investigations at the Legal Clinic at DePaul University College of Law in Chicago.

Dr. Jeffrey Janofsky, Associate Professor and Director of the Psychiatry and the Law Program at The Johns Hopkins Hospital, has testified about the pitfalls of drug recognition experts.

Jeffrey Gilleran is the Maryland public defender who successfully challenged drug recognition experts through Dr. Janofsky's testimony.

Michele LaVigne was a Wisconsin state public defender before joining the University of Wisconsin's clinical law faculty. She directs the Remington Center's Public Defender Project, in which law students are placed as interns in public defender offices throughout Wisconsin. Her work on language impairment examines the communicative, behavioral, and legal implications of language impairments frequently found in juvenile and criminal justice systems.

Kevin McClain is a private investigator in Illinois who formerly worked for the Office of the Illinois State Appellate Defender. An expert in investigative work involving social media, McClain is a frequent speaker at criminal defense training colleges nationwide, including the Darrow Death Penalty Defense College in Chicago.

Ann Roan has been the State Training Director for the Colorado State Public Defender for ten years and has been a public defender for 24 years. An expert in jury selection, Roan has taught criminal defense lawyers in Kentucky, Louisiana, and Texas, as well as at the National Criminal Defense College in Macon, Georgia, and at the NACDL's Capital Voir Dire College in Boulder.
