#### **GUEST SPEAKERS:**

**Justice Darryl L. Hecht** practiced law in Sioux City for twenty-two years before his appointment to the Iowa Court of Appeals in 1999. He was appointed to the Iowa Supreme Court in 2006.

**B. John Burns** is an Assistant Federal Public Defender, former Assistant Public Defender and former Assistant Appellate Defender. He is the author of the Iowa Practice series book, Criminal Procedure. His Case Law Update has become a yearly tradition for the Public Defender Association's CLE.

**Betsy Clarke** is the founder and President of the Juvenile Justice Initiative. She served as Juvenile Justice Counsel for the Cook County Public Defender for six years, and served for 15 years at the State Appellate Defender.

Steven J. Drahozal is an Assistant Public Defender for the Dubuque Office. Before joining the Public Defender Office in October 2014, he was in private practice where he practiced primarily in state post-conviction and appellate cases as well as federal criminal defense.
